SECTION 4 : FIRST AID MEASURES

EYE CONTACT : Contact with eyes can produce burning sensation. Irrigate with water immediately, continue flushing eyes with water for 15 minutes. Seek medical attention if irritation persists.

Keep away from extreme heat and from freezing conditions and away from all sources of ignition. Make sure the material does not come into contact with substances listed as: "Materials to Avoid".
